New Procedure for P&I Policy Review implemented by Maritime Port Bureau, MOTC

- 1. Basis: Based on Article 3 of the Regulations on Port Services at Commercial Ports as well as Article 15 of the Regulations for Administrating Shipping Agency, all vessels entering Taiwanese ports shall provide P&I policy or the certificate of insurance for MPB's review.
- 2. Purpose: In order to keep the territorial waters and harbors environmental safe and orderly as well as to prevent any occurrence of P&I insurers failing to deal with casualty, MPB will implement the new reinforced P&I policy review procedure starting from 1st Sep 2022.
- 3. The procedure (please refer to the procedure chart of the Attachment 1):
- A.The shipping agents shall fill in the required information on the P&I Policy Registry of MTNet and upload P&I policy/ the certificate of insurance.
- B.All P&I insurers are categorized into whitelist insurers, general list insurers, alerted list insurers and blacklist insurers. The policies issued by the whitelist insurers are unnecessary for reinforced review, while MPB will randomly check the policies issued by the general list insurers. The policies of the alerted list insurers shall be reviewed. The policies of the black list insurers shall be disapproved of the application. (Please refer to the Attachment 2, the whitelist insurers and

- the blacklist insurers. The category of the insurers may adjust from time to time. It is suggested checking the home page of MTNet when necessary.)
- C. The P&I policies approved by MOTC shall link with the registration of "one-voyage/ direct navigation, mini three-links transportation per vessel per voyage" as well as "the port entry/ departure application". The shipping agents have to upload the ship's P&I policy once only and provide the new policy after renewal.

4. The items for review:

- A.The minimum insured value shall subject to 162 SDR for each GRT. The GRT of a ship of less than 400 tons shall be deemed to be 400 tons.
- B.Wreck removal and environmental pollution liabilities.
- C.Crew and third parties liabilities for death & injury which shall not be less than NT\$ 2.5 million per person.
- D.Collision liability to fixed and floating objects.
- E.Liability for collision or other reasons causing damage to other vessel(s).
- F.Cost for life salvage.
- G.Under MLC 2006 for crew wage and repatriation liabilities.
- H.For some certificate of insurance with specific requirement for its P&I insurance, the shipping agents have to provide the relevant documents required by the insurer.
- I.If the insurers put strict requirements for the claim indemnity,

the policy review will not be approved.


5. Period of policy review

The period of policy review is three working days. For emergent case, the period of policy review is 24 hours prior to ship's entry/ departure application,.


