## 中華民國國際海事組織準法律文件履行章程推動小組 設置要點

- 一、為完備中華民國履行船旗國、沿岸國、港口國之責任與義務，與國際接軌，使我國海事管理制度與執行符合國際海事組織發布國際海事組織準法律文件履行章程(IMO Instruments Implementation Code, 以下簡稱 III Code)，特設中華民國國際海事組織準法律文件履行章程推動小組（以下簡稱本小組）。
- 二、本小組任務如下：
  - (一) III Code 政策、措施及行動方案之擬訂及推動，建立預防措施，提升海事系統績效。
  - (二) III Code 各項議題涉機關(構)權責之協調與追蹤檢討。
  - (三) III Code 稽核計畫之各項會議與相關行政作業。
- 三、本小組置召集人一人，由交通部航港局局長兼任之，其餘成員由下列機關(構)派員兼任之：
  - (一) 國家運輸安全調查委員會。
  - (二) 內政部。
  - (三) 行政院環境保護署。
  - (四) 國家通訊傳播委員會。
  - (五) 行政院國家搜救指揮中心。
  - (六) 交通部航政司。
  - (七) 海洋委員會海巡署。
  - (八) 海洋委員會海洋保育署。
  - (九) 國防部海軍大氣海洋局。
  - (十) 內政部空中勤務總隊。
  - (十一) 經濟部工業局。
  - (十二) 經濟部能源局。
  - (十三) 交通部中央氣象局。

(十四) 臺灣港務股份有限公司。

(十五) 財團法人中國驗船中心。

四、本小組下設四個工作分組，並得視需要再增設工作分組，

主辦機關(構)如下：

(一) 船舶分組：交通部航港局。

(二) 船員分組：交通部航港局。

(三) 航安分組：交通部航港局。

(四) 港區事務分組：臺灣港務股份有限公司。

各工作分組得視需要邀集有關機關(構)協辦。

五、本小組以每六個月召開會議一次，必要時得召開臨時會議，會議主席由召集人擔任，召集人因故不能出席會議時，由其指定人員代理之。

工作分組得視相關議題邀集本小組成員，隨時召開分組會議，召集人由各分組主辦機關(構)派員擔任。

前二項會議得邀請相關機關(構)、專家、學者或團體與會討論。

六、本小組幕僚作業，由交通部航港局兼辦之，各工作分組幕僚作業由各分組主辦機關(構)負責辦理。

七、本小組組成人員、工作分組及幕僚工作人員均為無給職。

## R. O. C. Guidelines for the Establishment of the III Code Promotion Group

1. In order to fulfill the Republic of China's (R. O. C.) responsibilities and obligations as a Flag State, Coastal State and Port State, to align with international standards, and to facilitate R.O.C. maritime management system and its compliance with the IMO Instruments Implementation Code (hereinafter referred to as III Code) issued by the International Maritime Organization (IMO), an R.O.C. III Code Promotion Group (hereinafter referred to as the Group) is established.
2. The tasks of the Group are as follows:
  - (1) The formulation and promotion of III Code policies, measures and action plans, the establishment of preventive measures, and enhancement of the maritime system performance.
  - (2) The coordination and follow-up reviews of various III Code issues that are connected with the authority of various agencies (institutions).
  - (3) The coordination of various III Code audit plan meetings and their related administrative operations.
3. The Group shall have one convener, which is served concurrently by the Director General of Maritime Port Bureau (MPB) of the Ministry of Transportation and Communications (MOTC), and various members, which are served concurrently by personnel from the following agencies (institutions):

- (1) Taiwan Transportation Safety Board
  - (2) Ministry of the Interior
  - (3) Environmental Protection Administration, Executive Yuan
  - (4) National Communications Commission
  - (5) National Rescue Command Center, Executive Yuan
  - (6) Department of Navigation and Aviation, Ministry of Transportation and Communications
  - (7) Coast Guard Administration, Ocean Affairs Council
  - (8) Ocean Conservation Administration, Ocean Affairs Council
  - (9) Naval Meteorological and Oceanographic Office, Ministry of National Defense
  - (10) National Airborne Service Corps, Ministry of the Interior
  - (11) Industrial Development Bureau, Ministry of Economic Affairs
  - (12) Bureau of Energy, Ministry of Economic Affairs
  - (13) Central Weather Bureau, Ministry of Transportation and Communications
  - (14) Taiwan International Ports Corporation, Ltd.
  - (15) CR Classification Society
4. This Group is composed of four divisions, and additional divisions may be added as necessary. The organizing agencies (institutions) are as follows:
- (1) Vessel Division: Maritime Port Bureau (MPB) of the MOTC.
  - (2) Crew Division: MPB of the MOTC.

- (3) Aviation Safety Division: MPB of the MOTC.
- (4) Port Affairs Division: Taiwan International Ports Corporation.

Each division may invite relevant agencies (institutions) to collaborate with the organization as necessary.

- 5. The Group shall meet once every six months, and may convene ad hoc meetings when necessary. The convener shall be the chairman of the meeting, and if the convener is unable to attend the meeting for any reason, the person designated by the convener shall act on his behalf.

The divisions may invite the members of the Group, depending on the respective issues, and convene a division meeting at any time, with the convener assigned by the organizer of each division.

Relevant agencies (institutions), experts, scholars or organizations may be invited to participate in the discussions in the meetings, as mentioned in the preceding two paragraphs.

- 6. The staff operation of the Group shall be supported by the MPB of the MOTC, and the staff operation of each division shall be the responsibility of the organizer of each division.
- 7. All members of the Group, the Division and the administrative staff are non-remunerated.
